ANY PERSON WHO OWNS, KEEPS, OR HARBORS A DOG MORE THAN THREE MONTHS OF AGE MUST FILE AN APPLICATION FOR REGISTRATION EACH YEAR.

| Kennel license fee after January 31 (Extended to Feb. 28). Includes late penalty  | \$200.00* |

\*VENDOR LICENSE IS REQUIRED IN ORDER TO PURCHASE A KENNEL LICENSE. THE COST IS \$25.00 WHICH IS A ONE TIME FEE AS LONG AS THE VENDOR LICENSE IS ACTIVE. YOU CAN ONLY PURCHASE A KENNEL LICENSE FROM THE AUDITOR'S OFFICE.\*

If a dog is licensed in any county in Ohio and the owner moves to another county in Ohio, that current license will be honored by that county for the remainder of the year. The owner should notify the county where the license was issued of the change of address.

When you have your pet spayed or neutered, you not only contribute to the solution of pet overpopulation, you also reduce the risk that your pet will contract certain cancers or develop aggressive tendencies.
